Hana Bank USA, National Association ("HBU"), formerly BNB Hana Bank, N.A., and KEB Hana Bank USA, National Association ("KEB Hana"), opened for business on September 16, 1986. Hana Bank USA is a wholly owned subsidiary of Hana Bancorp, Inc., which is owned by Hana Bank in Seoul, South Korea, a subsidiary of the Hana Financial Group. Hana Bank USA has its corporate office located at 222 Bridge Plaza South, Suite 730, Fort Lee, NJ 07024. Hana Bank USA has four (4) branch offices located in New York County and Queens County, New York; Bergen County, New Jersey; and Los Angeles County, California. Branch Offices provide full services, including loan and deposit products and services to businesses and consumers within the assessment areas delineated below:

Delineation of Assessment Area

Hana Bank USA has one Assessment Area that covers thirteen (13) counties located in New York, New Jersey, and California. The New York and New Jersey counties are located within three (3) Metropolitan Divisions (MDs) that are part of the New York-Northern New Jersey-Long Island, NY-NJ-PA Multistate Metropolitan Statistical Area (MMSA) (35620): Eight (8) counties are in the New York-White Plains-Wayne, NY-NJ MD (35614), two (2) counties are in the Newark, NJ-PA MD (35084), and one (1) county is in the Nassau County-Suffolk County MD (35004). Los Angeles and Orange Counties are part of the Los Angeles-Long Beach-Anaheim, CA Metropolitan Statistical Area (MSA) (31080).

1. New York

All of the Bronx County, Kings County, New York County, Queens County, Westchester County, and Nassau County have been delineated as the bank's assessment area. Hana Bank USA has two (2) branch offices in New York County and Queens County at below locations:
